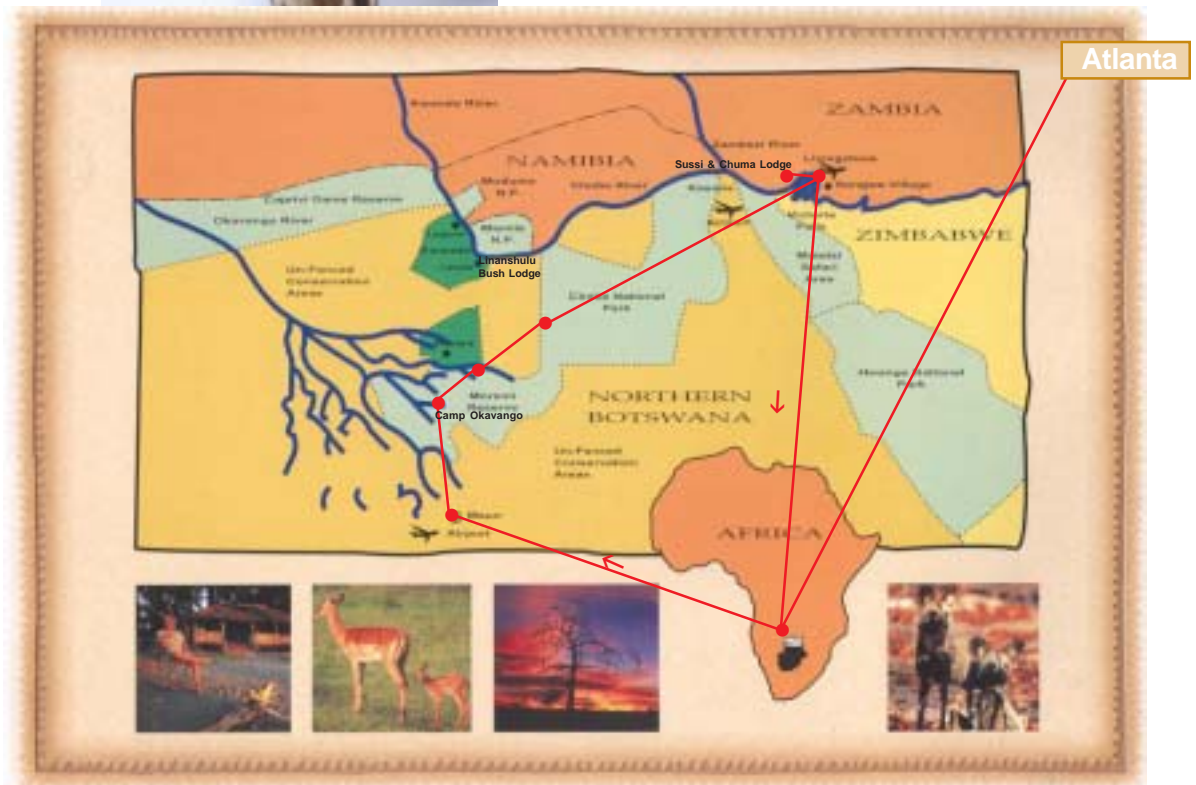

Day 1 Sunday, August 7, 2005

KANSAS CITY / ATLANTA

Depart Kansas City this afternoon aboard Delta Airlines flight to Atlanta. Upon arrival, proceed to the **Westin Airport Hotel**. (S)

Day 2, Monday, August 8

ATLANTA / JOHANNESBURG

Return to the airport this morning and check-in for your transatlantic **South African Airways** flight to Johannesburg, South Africa. Enjoy fine hospitality as you whisk your way across the Atlantic towards the continent of Africa. (D/S)

Day 3 Tuesday, August 9

JOHANNESBURG

Early afternoon arrival in Johannesburg, South Africa; where you are met and transferred to the **Westcliff Hotel**, in one of the fine residential suburbs of the city. The remainder of the day is at leisure. Enjoy dinner and overnight at the Westcliff Hotel. (B)/D

Day 4 Wednesday, August 10

JOHANNESBURG / MAUN / OKAVANGO DELTA - -

Camp Okavango

This morning, return to the airport for your Air Botswana flight to Maun. Continue by charter flight to **Camp Okavango's** private airstrip. Located on the remote Nxaragha Island, in the heart of the permanent Okavango Delta, your camp assures a year-round water wilderness experience. Stay in elegant East-African-style

safari tents, individually situated on raised teak platforms. Each tent is exquisitely furnished with African teak and colorful woven rugs, has en suite bathroom facilities and private sundecks. The elegant public areas in your camp will provide opportunities to enjoy wonderful al fresco dining in the expansive open air patio as well as dips in the delightful plunge pool during the hot midday hours. Arrive in time for a late afternoon game activity. B/L/D

Day 5 Thursday, August 11

OKAVANGO DELTA - **Camp Okavango**

These days are spent in the Okavango Delta, renowned for its natural beauty and diversity; famed as a haven for the rare Sitatunga antelope, and also as a birdwatchers paradise. Here you discover the secrets of the Okavango wetland ecosystem. All game viewing activities are conducted by experienced resident naturalist guides, and your days include exploring the Okavango by canoe and river-craft on wildlife and bird watching expeditions. Guided nature walks on the islands of the Delta afford an opportunity to track some of the larger species that inhabit this water wilderness. B/L/D

Day 6 Friday, August 12

OKAVANGO DELTA - **Camp Okavango / Camp Moremi**

Depart **Camp Okavango** by boat transfer to **Camp Moremi**, situated on the beautiful Xakanaxa Lagoon within the Moremi Game Reserve. Xakanaxa is renowned as one of the best game viewing areas in Botswana. Here, where the life-giving waters of the Okavango meet up with the vast Kalahari, ancient Mopane forests, open grassland, seasonal floodplains and riverine habitats have formed, creating one of the most magnificent and welcoming animal sanctuaries in all of Africa. Your exclusive camp consists of only 11 tents in intimate walk-through East African style with en suite facilities. Enjoy a game drive this afternoon in this pristine wilderness, seeking elephant, buffalo, zebra, giraffe, lechwe, sable and roan antelope as well as lion, leopard, cheetah and wild dog. B/L/D

Days 7/8 Saturday/Sunday, August 13/14

OKAVANGO DELTA - Camp Moremi

Enjoy two full days of game viewing. Moremi Game Reserve supports the most diverse habitat and animal populations in Botswana with possible sightings of wild dog, cheetah and leopard. Resident species include lion, elephant, buffalo, hippopotamus, giraffe, hyena, zebra, kudu, lechwe, sable and roan antelope. Thrill to the excitement of tracking these in open vehicles conducted by resident naturalists. There is also excellent bird-watching and the opportunity of exploring the lagoon by powerboat. In the evenings, relax in the elegant dining room and stylishly decorated cocktail bar. B/L/D



Day 9 Monday, August 15

OKAVANGO DELTA / SAVUTI CHANNEL

Board your charter this morning for the short flight to Savuti Airstrip. Continue overland in a 4 x 4 safari vehicle to the unique *Savuti Game Lodge*. The European design of the suites, with their spacious interior and large glass sliding doors, set this lodge apart from typical safari accommodation. Private viewing decks and en-suite facilities combine luxury and comfort with a classic wilderness experience. After lunch when you have had time to relax, you set out on the first of your game drives in this magnificent wilderness. Here herds of elephant, buffalo and different antelope species may be easily observed. The predators lion, leopard and cheetah, as well as hyena and wild dog can also be seen. Your game drives are in open safari vehicles for close encounters and exceptional photography. Return to camp for dinner under the stars and the unforgettable sounds of the African night. B/L/D

Day 10 Tuesday, August 16

SAVUTI CHANNEL - Savuti Game Reserve

Today is a full day of game drives, both morning and evening, in this dynamic wilderness, a sweeping expanse of savannah with brooding rocky outcrops. Mysterious wet and dry cycles mould this landscape and dictate the nature of its wild inhabitants. Game drives provide the opportunity for you to see the Savuti ecosystem, renowned for its large concentration of elephant and large lion prides. Here you will also seek the African wild dog, which now hunt in the channel where crocodiles swam only twenty years ago. The Gubasta Hills shelter leopards, klipspringer and one can find rock paintings of early man's wildlife sightings. Return in the evening to your luxury lodge where Marabou storks roost in the trees near the bar, which is situated in an exquisite thatch and timber main building. On the upstairs viewing deck, with your favorite beverage in hand, you will be mesmerized by the enchanting sunsets. B/L/D



Day 11 Wednesday, August 17

**SAVUTI CHANNEL / MOSI OA TUNYA NATIONAL PARK
- Victoria Falls**

After breakfast this morning the group will transfer to the airstrip for the charter flight to Livingstone, Zambia. Here you are met and taken to the *Sussi & Chuma Lodge*, situated on the northern edge of the Mosi Oa Tunya National Park, where luxurious tree houses hide discreetly among giant ebony trees, on a sweeping bend of the Zambezi River. Activities today include river cruises, game drives and walks with experienced guides. Visit the Zambian side of Victoria Falls to experience the might and splendor of this magnificent natural wonder. B/L/D



Day 12 Thursday, August 18

MOSI OA TUNYA NATIONAL PARK - *Livingstone*

A full day to explore in this beautiful area starting after breakfast with a game drive in open safari vehicles to view the amazing wildlife found here. In the evening, a night game drive with spotlight will give you the opportunity to have a glimpse of the creatures of the night; hyena, genets, civets and even the elusive leopard. Return to camp for dinner and overnight. B/L/D

Day 13 Friday, August 19

LIVINGSTONE / JOHANNESBURG / ATLANTA

This morning is your last breakfast in the bush, and then transfer to the Livingston Airport for your South African Airways flight to Johannesburg. Here the group will remain in the transit area, with excellent shopping and welcoming restaurants before boarding your *South African Airways* overnight flight to Atlanta. B/(D)

Day 14 Saturday, August 20

ATLANTA / KANSAS CITY

Your group will arrive at Atlanta's Hartsfield International Airport in the early morning. After clearing entry formalities, connect onto your flight to Kansas City and home. (B)
